LOCATION: North wall of the C-335 Process Building between columns Q34/S34.

APPROXIMATE DIMENSION OR CAPACITY: 217 ft²

FUNCTION: Temporary storage of materials

BRIEF HISTORY: Most of the material storage areas in the C-335 Process Building were created to consolidate excess material and equipment scattered throughout the building in order to provide additional nonradiological floor space. This area was released by the United States Enrichment Corporation to the U.S. Department of Energy (DOE) as a DOE Material Storage Area (DMSA) on December 31, 1996. From June 2006 to March 2008, DOE characterized materials in this DMSA in accordance with the DMSA Characterization/Remediation Plan, which was incorporated as Appendix E of the 2003 Agreed Order. The *Final Inventory and Characterization Report* (FI/CR) was submitted May 19, 2008, to the Kentucky Division of Waste Management (KDWM). KDWM approved the FI/CR on June 17, 2008.

Resource Conservation and Recovery Act (RCRA) closure was not required for this SWMU, since no hazardous wastes were stored in this unit, per the 2003 Agreed Order.

PRESENT OPERATIONAL STATUS: Inactive

DATES OPERATED: 1996 to 2008

SITE/PROCESS DESCRIPTION: An inside DOE storage area located along the north wall of the C-335 Process Building.

WASTE DESCRIPTION: This SWMU currently is empty. The Toxic Substances and Control Act polychlorinated biphenyl bulk product waste formerly stored consisted of process motors. These waste items also were classified as low-level waste (LLW) due to radiological contamination. No asbestos-containing material was present in the DMSA. Examples of LLW formerly stored included a freezer sublimator Freon condenser (unused), process pipe/process pipe with expansion joints or a spool piece, ventilation louvers, a scoop, and scrap metal. A detailed description of the characterization can be found in the FI/CR.

WASTE QUANTITY: Currently 0 ft³; waste quantity removed 808 ft³
